

# How Do I Know If My Site is Eligible to Join the National System of MPAs?



#### **June 2015**

The sites shown on the attached Program Summary Sheets are eligible to join the National System of Marine Protected Areas (MPAs). The national system connects and strengthens the nation's diverse marine protected areas, providing opportunities for federal, state, territorial and tribal programs to work together on shared priorities, as called for by Executive Order 13158. **The national system does not bring state, territorial or local sites under federal authority or control.** The proposed designation as part of the National System of MPAs does not change the current management of these sites in any way. Rather, it provides recognition that these sites contribute to national conservation objectives and an opportunity to work together with other protected areas on common issues.

The data listed for each site reflects the current management of the site, and are taken from the MPA Center's MPA Inventory. These sites have been determined to be eligible for the national system because they meet most of the entry criteria specified in the Framework for a National System of Marine Protected Areas of the United States of America.
